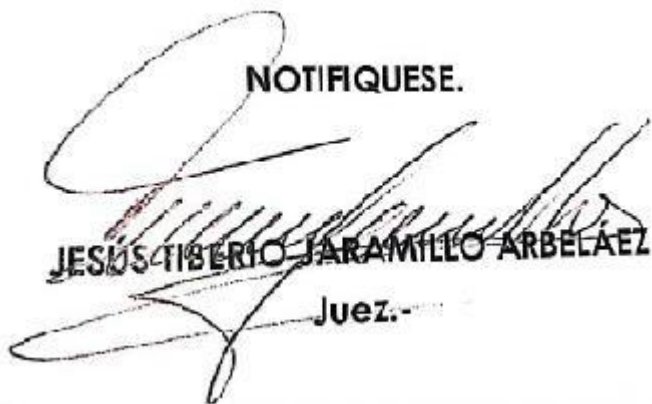
En mérito de lo expuesto el Juzgado Segundo de Familia de Oralidad de Medellín,
